



Brisbane and Queensland are preparing to host the world at Brisbane 2032, providing a transformational opportunity for businesses and communities across the state.

With a commitment to hosting a climate-positive Games, Brisbane will showcase Queensland's focus on the principles of sustainability, diversity and inclusion.

In the lead up to Brisbane 2032, there are likely to be significant benefits for Queensland's international education and training sector in areas such as the provision of elite athlete training and development opportunities, as well as for students selecting the state as a study destination.

There are opportunities being investigated for the sector statewide in relation to training hubs and facilities, promotion of research expertise and program management and cultural engagement in the lead up to the events.

As the events draw closer, the global spotlight will be firmly on Queensland which will naturally generate additional unique opportunities for international students who choose to start their future in Queensland.

# INTRODUCTION

Every year, more than five million students globally select an international destination to extend their education and training.

Nationally, Queensland attracts the most diverse student cohorts from around the world who contribute significantly to the communities in which they live, study and work. These students bring diverse cultures and languages, strong global competencies and extensive international networks.

The impacts of the COVID-19 pandemic on the international education and training (IET) sector in Queensland have been significant. Following seven years of consecutive growth the sector declined by over \$1 billion from 2020 to 2021. While the nature of the IET industry means that the impact of the losses will be felt for years to come, there are positive signs of recovery with marked increases in offshore interest and student visa lodgements.

As the world continues to transition through the pandemic, the global environment remains dynamic. There are ongoing challenges with travel mobility, rapidly changing geopolitical issues and new models of education and training that are impacting study destination decisions.

At the same time, the global war for talent has intensified. A recent paper from the World Economic Forum posited that "heading into 2022, talent scarcity is one of the key lenses through which we will see the entire world of work<sup>1</sup>."

In Australia, the unemployment rate has fallen to 3.5 per cent (as at 2022), the lowest rate since 1974. At the state level, research by Jobs Queensland indicates that an additional 280,000 people will be needed to fill jobs across the state by 2025. The national Jobs and Skills Summit in 2022 prioritised actions to strengthen the pipeline of skilled talent including the extension of visas and relaxing work restrictions on international students through to 30 June 2023, improving visa processing times and increasing the permanent Migration Program ceiling. The delays in visa processing and access to accommodation remain two significant challenges for the sector as international student numbers continue to grow.

The Queensland Government is committed to working with all levels of government to address current and future challenges and will advocate to the Australian Government for visa processing support and housing availability and affordability.

The IET sector has a role to play in addressing the talent shortage. Building stronger relationships between international and domestic students with local business and industry can deliver benefits for all parties. The skills and diversity of our international students help drive innovation, and this will become increasingly important in the lead up to Brisbane 2032 which will amplify investment and economic growth opportunities across the state.

Queensland is leveraging the benefits of its strong health response to drive recovery and a growing economy through three priorities: good jobs, better services and great lifestyle. The focus is on positioning Queensland to grow by attracting people, talent, and investment, and driving sustainable economic prosperity. The government has developed strategies and roadmaps in sectors including advanced manufacturing, aerospace, biofutures, biomedical, defence and mining equipment, technologies and services. The Queensland Energy and Jobs Plan will also create a pathway for more jobs in more industries across regional Queensland.

Alongside this support, investments in Queensland's innovation ecosystem are also reaping rewards. Building on the state's science and research expertise, Queensland is now home to multiple startups valued at over \$1 billion such as GO1, Tritium and SafetyCulture that are making an impact locally and around the world.

Collectively, Queensland represents an attractive cutting-edge, vibrant and dynamic study destination for students to attain world-class education and training and connect with local communities.

This Strategy lays the framework for investing in initiatives that will support the Queensland IET sector to thrive. The benefits to be realised from this whole of government Strategy are significant – for students, industry, our communities, and the Queensland economy.

The Strategy will focus activities over the next five years to position Queensland as a quality education destination with strong global networks and business connectivity, backed by a diverse and thriving sector.



### Queensland's expanding global network of education specialists




The Queensland Government has expanded the already significant network of specialists supporting the Queensland IET sector including:

International students seeking quality skills and career outcomes will find that a Queensland-based education pathway can take them anywhere.


Preparation for Brisbane 2032 will set Queensland apart by not only targeting study areas but also offering unique opportunities for community engagement.

Diversifying our markets and services will expand the range of education options available to students and help maintain competitiveness as global demand for talent continues to grow.


There are also opportunities to further strengthen international student engagement with local business and industry and connect research expertise, build future workforce skills, and foster economic development.

Continued advocacy across all levels of government will highlight the importance of international students for our future economic and social development.



We will support the student experience and promote and showcase the contribution of international students to Queensland.


We will continue to foster and advocate for policy settings that support international students and the sector across the state.
